## **Purpose of Staff Report**

The purpose of this Staff Report No. 01-20-SPA is to seek the Source Protection Authority's approval of appointments of members to the Source Protection Committee.

# **Background:**

The Clean Water Act directs all Source Protection Regions to establish a Source Protection Committee, the members of which shall be responsible for developing and monitoring the implementation of a Source Protection Plan. In the case of the South Georgian Bay — Lake Simcoe Source Protection Region, the committee has been defined as being composed of a Chair, plus 22 members. Furthermore, members are to include one First Nations representative, and seven

representatives each from the municipal, economic/industrial sectors, and public at large. In the case of Source Protection Regions, the Lakes Simcoe/Couchiching Black River Source Protection Authority (SPA) as the lead SPA is responsible for appointing members to the Source Protection Committee, as well as filling vacancies which may arise.

In addition to defining the size and structure of the Source Protection Committee, a Regulation under the *Clean Water Act* also sets term limits for Committee members at 5 years. As such, 14 of the 22 Committee members saw their terms end in December 2019, leading to vacancies which need to be filled. Sadly, another long-standing and well-respected member of the committee passed away in January of this year, leading to another vacancy.

The 15 vacancies on the South Georgian Bay – Lake Simcoe Source Protection Committee includes three municipal representatives, seven public sector representative, and five representatives of the economic/industrial sector.

## Issues:

As per direction provided by Provincial Regulation (O. Reg. 288/07), the process used to seek replacement of municipal sector representatives is different from that used to identify economic and public representatives.

Municipal sector representatives are to be appointed by local Source Protection Authorities, based on candidates recommended by local municipalities. As the municipal vacancies are representatives of Nottawasaga Valley and Severn Sound Source Protection Authorities (one and two vacancies, respectively), those appointments will be made by their respective Boards of Directors. An update on those applications will be brought to this Board at its next meeting.

To seek applicants for the public and economic/industrial representatives, advertisements were posted on the Source Water Protection Region's website and notices were placed in newspapers throughout the Region. This process resulted in five applicants for the economic sector (which had five vacancies), and ten applicants for the public sector (which had seven vacancies).

A Selection Committee was struck, comprised of senior management from the three Source Protection Authorities, as well as the Chair of the Source Protection Committee. The Selection Committee discussed and evaluated the applications and recommends the following applicants be appointed to the Source Protection Committee:

- Economic / Industrial Sector representatives:
  - Colin Elliot agricultural sector (returning member)
  - John Hemsted agricultural sector (returning member)
  - David Ketcheson development consulting sector (returning member)
  - Brandon Powers development consulting sector (new member)
  - David Ritchie agricultural sector (returning member)

- Public representative:
  - Geoff Allan (new member)
  - Bob Duncanson (returning member)
  - David Greenwood (new member)
  - Stephanie Hobbs (returning member)

  - Larry Slomka (returning member)

# **Summary & Recommendations:**

As the lead Source Protection Authority, the Lakes Simcoe/Couchiching Black River Source Protection Authority is responsible for ensuring the Source Protection Committee meets the size and structure guidelines of the *Clean Water Act*. There are currently fifteen vacancies on the Committee, including three municipal representatives, five representatives of the economic/industrial sector, and seven public representatives. Municipal sector representatives are to be appointed by Nottawasaga Valley and Severn Sound Source Protection Authorities, to represent municipalities in their respective watersheds. Public and economic/industrial sector representatives are to be appointed by the lead Source Protection Authority. Applications for these positions have been received and evaluated.

It is therefore RECOMMENDED THAT Staff Report No. 01-20-SPA regarding the appointment of members to the South Georgian Bay – Lake Simcoe Source Protection Committee be received; and FURTHER THAT the appointment of Colin Elliot, John Hemsted, David Ketcheson, Brandon Powers, David Ritchie, Geoff Allan, Bob Duncanson, David Greenwood, Stephanie Hobbs, Tom Kurtz, Cate Root, and Larry Slomka to the South Georgian Bay – Lake Simcoe Source Protection Committee for a term of five years beginning January 1, 2020 be approved.
